## MediChipping

Every week we bring you what we call a Prophecy Update. We show how news and trends in the world are corroborating centuries-old prophecies found in the Bible.

The most infamous of all prophecies is the dreaded Mark of the Beast. The Mark of the Beast involves a person knowingly, willingly swearing his or her allegiance to the world leader we call the antichrist in the middle of the yet future Great Tribulation. The latest mark-of-the-beast technology news comes from Colorado. As reported this week by WNDHealth,<sup>1</sup>

A plan being proposed by three lawmakers in Colorado, Reps. Ken Summers and Tom Massey and Sen. Betty Boyd, would require consumers to submit to a biometric scan of their retina or provide a fingerprint in order to get medication.

The plan is HB12-1242 and is under consideration by the Colorado Assembly, which is deliberating the demand that "practitioners and PDOs (prescription drug outlets)" install and maintain "biometric scanning devices and to use those devices to obtain a biometric

scan of a person's biometric identifier, such as a fingerprint or retinal scan, and to submit the scan to the database.”

The pharmacies would have to “prior to prescribing or dispensing a prescription drug or dispensing a restricted over-the-counter substance... submit specified information to the [state] database.”

That information would include details about the drug and the doctor who prescribed it as well as the “name and address of the person receiving the substance.”

While we are talking medical micro-chipping,

... researchers at the Massachusetts Institute of Technology have spent 15 years developing an implantable microchip that will [deliver predetermined doses of medication]... Human trials started last year in Denmark, and the results of the in-body test were published in the February 15 online edition of *Science Translational Medicine*.

[The company that MIT helped form], MicroCHIPS... hopes to eventually offer chips that can hold hundreds of doses, and the company will spend the next several years refining this technology and working toward FDA approval.

"You could literally have a pharmacy on a chip," says MIT professor Robert Langer, who co-founded MicroCHIPS.<sup>2</sup>

All the way back in the first century the apostle John saw the world we are living in, the future that is now here, in which some sort of “mark” *on* or *in* our bodies would identify and track us.

I remind you that although we follow the fulfillment of Bible prophecy, we are not waiting for any prophecy to be fulfilled. Jesus promised to return to resurrect and rapture the church as an imminent event. By that we mean the certainty that He may come at any moment and the fact that no prophesied event stands between the believer and that hour.
