Several of you (and I thank you) sent me an article on a bill, HR4919. The tag line read, "HR4919 would allow the federal government to implement tracking chips into those with autism and developmental disabilities. It passed in the House on December 8th, 2016.

I'm always a little skeptical of these things, but this seems legit. One lawmaker who has read the bill is Rep Louie Gohmert of Texas. He had this to say:

I see where this goes. We will have a federal tracking program... The more I read this bill, the more I see a program George Orwell would be afraid of.

While this initiative may have noble intentions, 'small and temporary' programs in the name of safety and security often evolve into permanent and enlarged bureaucracies that infringe on the American people's freedoms. That is exactly what we have here. A safety problem exists for people with Alzheimer's, autism and other mental health issues, so the fix, we are told, is to have the Department of Justice, start a tracking program so we can use some device or method to track these individuals 24/7.
